

The reorganization meeting of Hanover Borough Council was called to order at 5:40 PM Monday Evening, January 6, 2014 in the Hanover Borough Council Chamber, 44 Frederick Street, Hanover, Pennsylvania with Mayor Adams presiding.

On roll call, the following members of Council were present: Mr. Eline, Mr. Funke, Mr. Gerken, Mrs. Griffin, Mr. Marcoccio, Mr. McLin, Mr. Morris, Mr. Reichart, Mr. Roth and Mrs. Yingling; Solicitor Yingst; Mayor Adams; Manager Krebs and Secretary Miller.

Secretary Miller reported that Certificates of Election and Certificates of Residency have been filed for the following recently elected Council Members and officials: Mr. Gerald Funke, First Ward Council; Mr. William W. Reichart II, Second Ward Council; Mr. Robert Marcoccio, Third Ward Council; Mr. Bernard (Sonny) Eline, Fourth Ward Council; Mr. James Roth, Fifth Ward Council; Mayor Ben Adams; and Tax Collector Leroy Wentz.

Magistrate Dwayne Dubs administered the Oath of Office to Mayor Ben Adams.

Mayor Adams administered the Oath of Office to Mr. Funke, Mr. Reichart, Mr. Marcoccio, Mr. Eline, Mr. Roth and Mr. Wentz.

Mayor Adams announced that Council was ready to reorganize for years 2014-2015 and that the Chair was ready to accept nominations for President and Vice President of Council.

Mr. Eline nominated Mr. John Gerken for President of Council.

Mr. Morris nominated Mr. Eline for Vice President of Council.

There were no other nominations for president or vice president.

The nomination for President passed 8-0 in favor of Mr. Gerken for Council President, with Mr. Funke and Mr. McLin voting in opposition to the nomination.

The nomination for Vice President of Council passed 10-0 in favor of Mr. Eline for Vice-President of Council.

Mayor Adams turned the Chair over to the newly elected President, Mr. John Gerken.

President Gerken thanked Council for electing him as President and Mr. Eline as Vice-President, and announced the floor was now open for nominations to the following appointed offices for 2014 - 2015: Borough Manager, Borough Secretary, Borough Treasurer, Assistant Borough Secretary, Assistant Borough Treasurer and Solicitor.



Motion carried.

Mr. Gerken thanked Council and staff for their attendance and support this evening.
