2018 PERMIT FOR OVERSIZE AND OR OVERWEIGHT VEHICLES

*Fees: \$50.00 PERMIT FEE/MOVEMENT * PLUS: Fifty [\$.50] for each 1,000 pounds (or fraction thereof) over & above 80,000 pounds gross vehicle weight per movement - On hundred [\$100.00] for each bridge crossing -Per Borough of Hanover Ordinance No. 2272 passed August 22, 2018

Hours of Operation per Ordinance No. 2272: Movements may be conducted within Hanover Borough limits between 9:00 am and 4:00 pm, Monday through Friday and between the hours of 7:00 am and 12:00 noon on Saturday with exceptions.

Hanover Borough Escort Requirements: One vehicle required if over 11' in total width OR in excess of 75' in length. Two vehicles required if over in BOTH width (11') and length (75'). For an oversize vehicle in excess of 14' in total height, a vehicle with a height pole is required. Per Codified Ordinance §513.08, section (f)6
